CHE/891/B.P. Spl Cell/AL/337 dt. 31.10.17 (MC Approval number MCP 1559 dt. 13.11.17.) and CFO N.O.C. u/no. FB/HR/RVI/119 dt. 29.9.17. The B.P. Approval for the proposal was for G+6 floors, however, as per User Requirement the construction was done till G+5 floors.
- 2. The work of the school bldg. u/r has been completed and the structural stability certificate dt. 11-11-2020 has also been received by this office from Structural Consultant.
- 3. Final NOC from CFO department for the completed work has been obtained u/no. FB/HR/RVI/107 dated 21.03.21.

As all the compliances required by the B.P. Dept are complied with and the school bldg is constructed as per the B.P. approved plans, this office hereby convey its concurrence for the occupation of the Municipal School Building on plot bearing CTS No. 301 of Hariyali Village, S ward, Vikhroli from architectural planning and circulation point of view.

Hariyali Village Municipal School is not having required electrical power load for running school in full capacity. M/s Adani Electricity is still pressing for substation space in the school. It is requested to resolve the issue at the earliest.
